Commissioner DeGroot approves minutes from last Work Session meeting.

**4. Judd Lehman, Fremont-Winema NF - Update**

Judd Lehman addresses Board discussing plan going forward to maintain the healthy/green forest and what they are doing to clean up/restore the burned forest areas. Shows map of areas that have been logged. Commissioner DeGroot questions how many board feet per year they are logging? Lehman responds on average 67 million but this last year was 113 million of which some was fire salvage. Commissioner Henslee questions how many of those projects are managed by ODF? Lehman responds quite a bit and elaborated. Commissioner DeGroot questions where the "receipts" end up? Lehman responds/explains. Commissioner Henslee asks if they are expanding the "forest management program"? Lehman stated they are currently slated to grow the program but may change depending on the new forest supervisor. Lehman continues they are trying to work with the Tribes to get a contract in place. Lehman indicates we could use another mill to be able to process the timber. Commissioner Henslee is excited to hear that we are logging and that we could even use another mill to keep up. Discussion about replanting and what type of trees they are planting. Last challenge they have is they need to keep up on prescribed fires, but they run into other issues such as smoke etc. Commissioner Henslee asks Lehman to email the Board a list of 5-10 talking points, accomplishments and plans for the future so they can share with the public.
