We've had the opportunity to partner on local incidents and had some training and I think there will be benefits for you even through other departments. We hadn't fully executed the MOU. The group further discusses specifics. The Board was in agreement to review the MOU and bring this topic back for discussion after the Golden Fire emergency.
